In case of death of the insured the remains will be repatriated to the homeland. However the family of the insured can, if applicable and reasonable, determine that the remains must be repatriated elsewhere.

Extra air travel insurance

Maximum sum insured EUR 4,000

The costs of air travel relating to the return to the country of residence concerning peril of death or death of a relative by blood or by affinity in the first and second degree, due to an accident or a life threatening disease.

Insured are:

- the policyholder and, if insured as the head of the family, the family consisting of;
- his/her spouse;
- the unmarried persons with whom he or she lives and forms a family unit;
- his/her minor children;
- his/her adult children in so far as resident with him/her or resident in student accommodations.
